Effective upon the recording of this Amendment, all of the Real Property, including the property constituting BUCKHORN RANCH FILING NO. 1, formerly AVION CLUB FILING NO. 1, shall be subject to the Declaration of Protective Covenants of Buckhorn Ranch filed the 3rd day of May, 2001 at Reception No. 570419 of the records of Gunnison County, Colorado. The Declaration of Protective Covenants of Buckhorn Ranch shall be binding upon all persons and entities having any right, title or interest in and to any lots, tracts, or parcels of land within BUCKHORN RANCH FILING NO. 1, and future owners of Lots or interests in the Real Property, their heirs, successors and assigns.

8. FAX SIGNATURES. Each of the undersigned parties agree that a signature submitted by telephone facsimile (FAX) shall be binding to the same extent as a document containing the original signature. In the event such document containing a FAX signature is utilized, the signer shall provide the actual document containing the original signature to the appropriate parties by regular mail without delay.

9. COUNTERPARTS. This Amendment and any other documents or instruments required under this Amendment may be executed in counterparts, each of which shall for all purposes be deemed an original and all of which together shall constitute one and the same agreement, document or instrument.
