AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN  
OF MT. CRESTED BUTTE, COLORADO, ANNEXING THE  
PROPERTY COMMONLY KNOWN AS THE "EAST TRADE  
PARCEL" INTO THE TOWN OF MT. CRESTED BUTTE,  
COLORADO

WHEREAS, a petition for annexation of the property commonly known as the "East Trade Parcel", more particularly described in the attached Exhibit A, was filed with the Town of Mt. Crested Butte, Colorado, on September 11, 2000, by CBMR Real Estate, LLC, a Colorado limited liability company, as owner; and

WHEREAS, the Town Council of the Town of Mt. Crested Butte, Colorado, has previously found said petition for annexation to be in substantial compliance with Colorado state law; and

WHEREAS, the Town Council of the Town of Mt. Crested Butte, Colorado, has previously determined that the property described in the attached Exhibit A is eligible for annexation to the Town of Mt. Crested Butte, Colorado, without an election pursuant to Colorado state law; and

WHEREAS, the Town of Mt. Crested Butte, Colorado, and CBMR Real Estate, LLC, have agreed upon the terms and conditions for the annexation of the property described in Exhibit A.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, THAT:

**Section 1. Annexation.** The real property described in Exhibit A, attached hereto and incorporated herein, is hereby annexed to and made a part of the Town of Mt. Crested Butte, Colorado.

**Section 2. Annexation Map.** The real property described in Exhibit A, and herein annexed, is depicted in the Annexation Map, attached hereto as Exhibit B.

**Section 3. Annexation and Development Agreement.** The annexation of the real property described in Exhibit A is subject to those provisions contained in the "Annexation and Development Agreement" executed by the Town of Mt. Crested Butte, Colorado, and CBMR Real Estate, LLC, as owner of said property.

**Section 4. Recording.** The Clerk of the Town of Mt. Crested Butte is hereby authorized and directed to record with the County Clerk of the County of Gunnison,

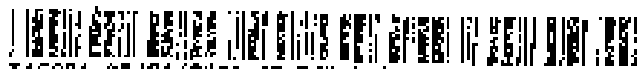
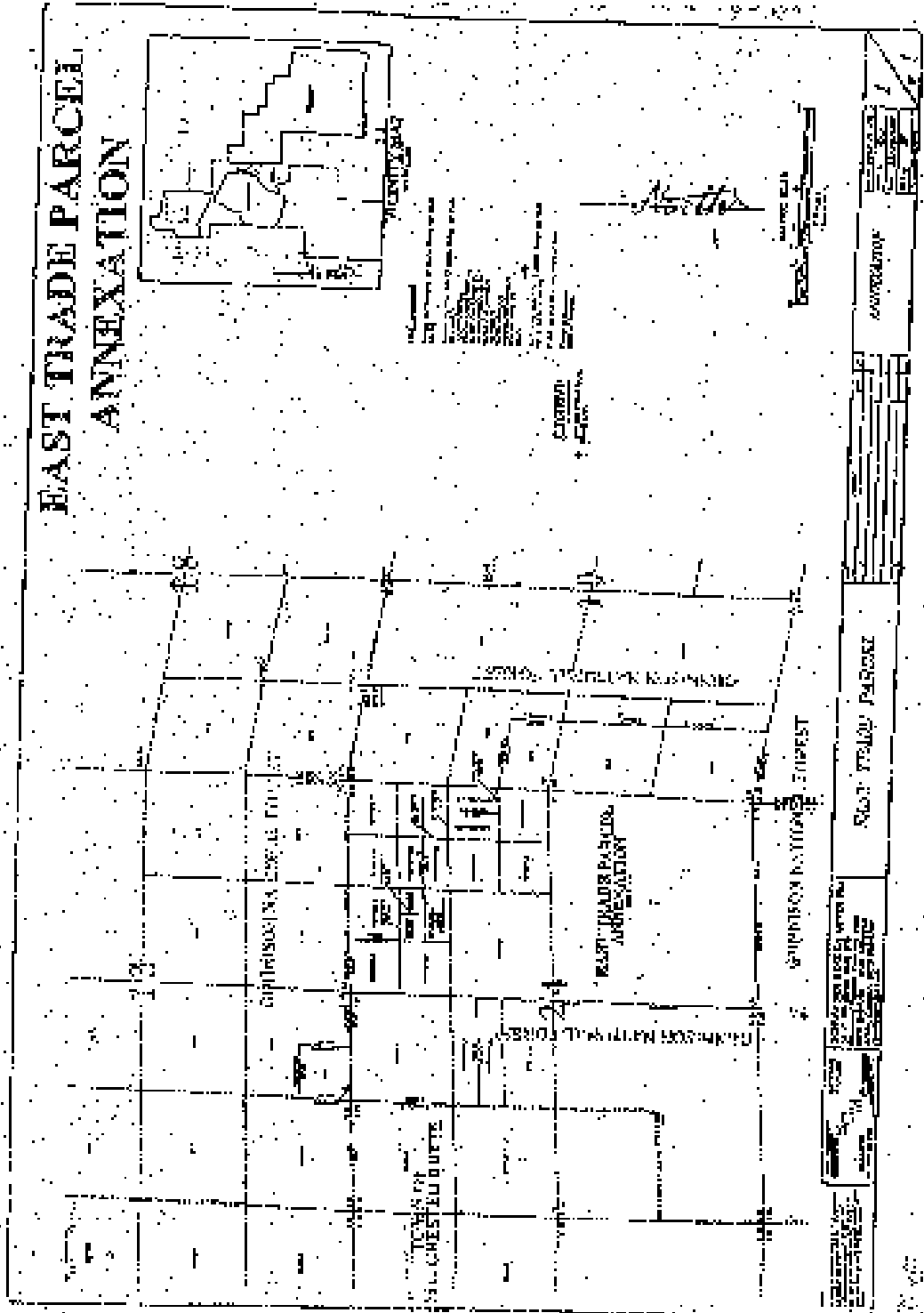
