**DECLARATION OF PRACTICAL USE AND USEFULNESS**  
**TO THE**  
**REVIEWERS AND EXAMINERS**

WILDEHORN, LORRAINE AND ASSOCIATES, Inc., filed a complaint on September 14, 1982 in Book 991 at page 354 of the records of the Cuyahoga County Clerk and Responded the plaintiffive covenants for Riverfront Apartments, Inc. and, additionally, the defendant, Cuyahoga Falls Venetian, wished to amend said declaration of plaintiffive covenants by the addition of a covenant prohibiting dogs at large upon the property.

Now, THEREFORE, the declaration of productive  
covenants of Riverland Industrial Park is hereby amended  
by the addition of the following provisions:

S(C)(1). No dog or other large pet shall be permitted upon my site without the payment of any sum, except pursuant to the following provisions:

1. A dog or other large pet may be kept within an enclosed motor vehicle, building, or within a fenced enclosure sufficient in strength and height to contain said dog or pet at all times; or
  2. Upon a leash no longer than 10 feet in length and in the control of the person owning or in charge of said dog or other pet.

The foregoing amendment to the protective covenants of Riverland Industrial Park was executed by Riverland Joint Venture, owner of more than 75 per cent of the lots in said subdivision, this 23<sup>rd</sup> day of December, 1983.
