**ARTICLE I.
Name**

The name of the corporation shall be BLACK DIAMOND LODGE CONDOMINIUM ASSOCIATION, INC.

ARTICLE II.

Period of and after the date of filing the Articles of Incorporation with the Colorado Secretary of State, unless dissolved according to law.

**ARTICLE III.
Members**

The corporation shall have voting members. Upon becoming an owner of a condominium unit in Black Diamond Lodge Condominium Association, Inc., the owner shall be entitled and required to be a member of the corporation for the period of ownership of a condominium unit in said condominium. 




